PRECINCT COMMITTEEMAN / COMMITTEEWOMAN APPLICATION

The Broward Republican Executive Committee (BREC) consists of "precinct committeemen" and "precinct committeewomen" who represent registered Republicans in their voting precincts. The role of precinct committee men and women is key to Republican success. The BREC is the basis for Republican grassroots efforts in Broward County and we rely on BREC members to meet and communicate with their "Republican" neighbors (Lists will be provided) in their voting precincts, help our Republicans to be informed, recruit new volunteers, and help your neighborhood Republicans to know when, where, and how to vote. As a member, you are also an Internal Voting member of the Republican party, and when you attend our meetings, your opinion and voice will be heard through your vote and will help transform our party into the party you believe it should be. In recent years our party has been transformed into the new Republican party of Common sense and it represents all Americans of all backgrounds. To join you must be a registered Republican for at least 365 days although if you are not, we will still accept you as a Non-Voting Volunteer until such time that you have achieved 365 days as a Republican.

In order to become a BREC member, you must provide:

- 1. This BREC application
- 2. Candidate Oath Precinct Committeemen and Committeewomen Notarized ******
- 3. RPOF Loyalty Oath
- 4. A copy of your Voter Registration Card Front and Back

You must reside in the precinct that you will represent (which is listed on your Voter Registration card and you may find this at Browardvotes.gov). The application and two forms containing your original signature and the copy of your voter registration card may be e-mailed to membership@BrowardGOP.org or given to an officer at a monthly BREC meeting, held the 4th Monday of every month. You may also find meeting information at BrowardGOP.com under "For Members" or on our event calendar.

You must attend 2 BREC meetings. At the second meeting your application will be voted upon. If voted on successfully, you will become a member.
